EcoOnline Terms and Conditions of Use

1 THE TERMS

The following Terms and Conditions (the "Terms") shall apply to and form an integral part of or be regarded as separate agreement entered into between EcoOnline and the customer or user of any of EcoOnline's services and applications, unless and to the extent EcoOnline and the Customer explicitly agree otherwise in writing.

By signing up or otherwise using the EcoOnline service, websites, and software applications, or accessing any content or material that is made available by EcoOnline through the Service (the "Content") you are accepting these Terms and EcoOnline's Privacy Policy. If the Terms or the Privacy Policy may not be accepted or complied with, then the EcoOnline Service shall not be used.

Any other standard or general terms and conditions not provided by EcoOnline are explicitly rejected and shall be disregarded by EcoOnline, irrespective of whether such terms and conditions are presented or referred to by customers or users.

2 RIGHTS AND OBLIGATIONS

2.1 Intellectual property rights

2.2 License grants

By accepting these Terms, a limited, non-exclusive, revocable license to use the Content for the individual customer or user will be granted, inclusive to make personal or internally non-commercial, use of the Content.

Upon purchasing services or software from EcoOnline, a limited, non-exclusive, revocable license for use of the services and the software will be granted upon payment, if credit is not agreed, to use the products and the services pursuant to these Terms. 2.3 User content

If you provide feedback, ideas or suggestions to EcoOnline in connection with the EcoOnline services, software or Content ("Feedback"), you acknowledge that the Feedback is not confidential, and you authorize EcoOnline to use that Feedback without restriction and without payment to you.

Any dispute between EcoOnline and a customer or a user shall be subject to the exclusive jurisdiction of the district court of Tønsberg ("Tønsberg tingrett").

Notwithstanding the foregoing, EcoOnline reserves the right to institute any legal proceedings against a customer or a user in any other jurisdiction where harm to EcoOnline is occurring.

12 TRIALS / RESTRICTED ACCESS

If a user is to carry out a free trial of the service, the free trial will begin on the day that the organization account (created on user signup for a free account to the web application) is created and the service will be made available free of charge for a period of fourteen (14) days.
